Referral Count

- New system doesn't allow to pull report- manually assembled, COVID affected this at some point
- Thrilled to find more kids but this puts strain on coordinators and therapy agencies;
 seeing behaviors that mimic ASD characteristics- different exposure levels during
 COVID, not necessarily diagnosed but that means a spike in referrals
- Fiscal report through the end of March
 - will end year within budget, a lot left in fiscal year
 - do have a lot of end-of-year expenses
 - no major change in spending costs
 - largest cost is payroll

HR Report for Dec.-Feb. 2022

- o Turnover is a struggle. Cluster D has always been a higher turnover office.
- Four resigned (2 maternity leaves not returned, 1 became a DT, 1 turned FS contractor)—Shout out to management team for their diligence in covering open caseloads!

5. Agency Updates:

- Amy Ellis (Homefront Director): most challenging time in 25 years, 3 new providers (OT in Montgomery, OT in White, ST in Fountain); still drowning in referrals, stuck with assigning kids to provider who tries to squeeze a family in or can't at all because family doesn't get the time they want
- Brooklyn Dugdale (Bona Vista): similar experience as Amy- struggling to get new providers, lost some to school and nursing home, assigning replacement providers is a challenge, interviewed a PT and ST recently, one mainly Howard and the other Howard/Cass/Miami
- Christian Swisher (Therapy Solutions): not in attendance but probably shares similar thoughts and experiences

- Grant (Childcare Resource Network)
 - Responsible for finding childcare or help with vouchers
 - Helping childcares get licensed or get involved in the process- applying for regional ready dollars- regional economic dev. Through FARPA, launching project in several of our counties to incentivize them to get licensed
- Libbi Smith (Clinton County Early Start Coordinator)
 - o Pretty quiet right now- need pregnant women, need navigator to help with insurance
 - o Baby Shower on August 5, 20022

- Susie sitting in as many meetings as she can.
- Healthy Families (virtual)- discussing different relationships between First Steps and other agencies
- Continuing to build relationship with DCS (MagiK List)
- Including Elise in intake meetings- helpful for parents to know the different options for a deaf/hard of hearing child and understanding the importance of these services when the babies are still really young
