

- Motion to Approve Last Meeting's Notes
 - Amy Ellis motioned to approve.
 - Elizabeth Sorguis seconded.
- SPOE Updates:
 - Discussed referral sources.
 - Explained that state used to be able to run reports. Unfortunately, those reports cannot be produced at this current time. We would love to be able to track children, how they move through the plan.

- 4. 1st Kids Update
 - Reports-
 - **Referral Count**
 - Nothing new here.
 - Fiscal Report from July 1 to June 30
 - We ended the year by overspending. That was by design and approved by the board. We get the allocations in one lump sum and the agency divides into their own categories- 90% of budget is spent on salaries. At this point in the new fiscal year, we have not have any unusual expenses.

HR Report for March-May 2022

- 15 full-time employees; 1 new employee; 1 employee left after report was run; new hire starting on October 3rd
- 2 vacant spots open; Lafayette has been a hard area to hire for. This cluster typically gets several employees affiliated with the University, but the time is brief. We were able to hire one intern.
- We discussed using Indeed to promote job openings.
- We also use word of mouth and social media. We do promote using social media to current employees.
- It was discussed that Purdue internship program is an excellent program.

5. Agency Updates:

Therapy Solutions-

-hired an OT for Benton County (part-time), lost a DT (Montgomery/Tippecanoe), maintaining the rest of the staff

-lots of referrals; statewide issues with providers- very full and trying to squeeze kids in when they can -starting conversations with service frequencies- thinking outside of the box but not overwhelming with kids, trying to focus on attendance policies; several providers have left because of lack of sessions and families not showing up for appointments

-some families are against virtual therapy but agency can provide it

Homefront:

-Providers are maxed out- trying to make alternations to their schedule

-hired a DT for the Lebanon area, had one DT move from one area to another but still in Cluster D -providers struggling with no shows or lack of scheduling- then not getting paid because the session didn't happen

-Providers are really getting frustrated with trying to track families down.

Locally, SPOES are limited on what they can to do to help prevent no shows. Agencies explained it is hard when one agency discharges a family due to no shows knowing the coordinator will just go to another agency and ask for the provider. Therapy Solutions mentioned that on their clinic side, if family no shows, they can still bill for reimbursement. First Steps can't. Cindy Lawrence from CDHHE also feels the frustration.

 - i. Event on 11-12-22 at the office in Downtown Lafayette.
 - ii. Trying to let parents know when childcares open up.
 - iii. Training and assistance went to a new contractor.

- 9. Concerns/complaints:

Assessment team meetings are quarterly, will be meeting in December. Assessment team is offering both in person and virtual evaluations, also struggling with families no showing or missing evaluations. We will continue to meet quarterly, keeping in mind the holiday season and summer break (since LPCC Meetings and Transition Team Meetings are usually on the same day). Management to discuss this schedule moving forward.
